The event was organized by Leaders League in conjunction with its partners: Practical Law Company, Association of Corporate Counsel (Europe), the Canadian Corporate Counsel Association, Licensing Executive Society, the European Company Lawyers Association, the European Lawyer, Magazine Decideurs, the International Council of Jurists, Global Turnaround, All India Bar Association, Global Turnaround, INSOL Europe, Cercle Montesquieu, Cercle Godel, and the French in-house Counsel Association.

Leaders League is a French independent information provider with offices in Paris and New York. Its main three fields of expertise are Law, Finance and Strategy. While a long time French reference through Magazine Decideurs it operates internationally through Intelligence reports and international prestigious events.

The Awards Ceremony on June 3rd recognized the best independent law firms for 28 categories from their domestic markets and countries.
